#### **NON-FOOD VENDORS: Rules & Regulations:**

- 1. NON-FOOD VENDORS: There are three (3) categories of VENDOR designations.
  - 1. **SALES**: Products & Novelties Gifts, services, and manufactured products that are being sold.
  - 2. **PROMOTION**: The sole purpose is to provide information or market the company and nothing is being sold.
  - 3. **NON-PROFITS**: an official 501©3 nonprofit that wishes to share information about their service or event.

All items sold and personal selling must be "G" rated.

2. BOOTH FEES: the fee for the event is based on booth location.

- 2. PROMOTION
  - □ 2-day event \$250.00
- 3. NON-PROFIT
  - □ 2-day event \$100.00

Booths are on a first come first serve basis. Fees must be received by May 1<sup>st</sup>, 2025. Booth fees are non-refundable without notice before the start of the event. Long-time vendors should apply and pay early to reserve their space(s).

3. SPACES: Booth spaces may be shared but must fit in one 10x10 space. You may rent multiple spaces, each additional 10x10 space is \$150.00. TABLES, CHAIRS, TENTS, CANOPIES ARE THE RESPONSIBILITY OF EACH VENDOR. Neither the River Reach Foundation nor the City will provide tables, chairs, tents, or canopies. The Parks Department does NOT have tents or canopies for rent.

<u>Driving stakes into the ground (park grass, bricks, or pavement) is not permitted;</u> weights such as sandbags should be used to hold down canopies/tents, (water buckets are acceptable). Repair costs caused by the vendor will be the responsibility of the vendor.

4. BOOTH ASSIGNMENTS: Specific spaces will be assigned to each vendor but cannot be guaranteed. Mobile vending, approaching, or soliciting eventgoers outside of your designated

10x10 booth space is NOT ALLOWED. Larger booths will be placed in locations with enough spacing to accommodate trails and public safety.

- 5. NEW MEXICO GROSS RECEPIT TAX ID NUMBER (CRS): Vendors are responsible for the sale tax liability for all items sold. New Mexico requires all vendors at Riverfest to have CRS#s for filing gross receipts tax.
- 6. HOURS: NON-FOOD VENDORS are ONLY 2-days SATURDAY & SUNDAY. NO SALES are allowed on FRIDAY. Friday setup would be 2-5pm. Booths may not break down until the event is over on Sunday after 5pm.
- 7. **SECURITY:** The security of materials is the sole responsibility of the exhibitor. Exhibitors should be prepared for winds and/ or rain. Overnight security is employed but cannot guarantee the safety of any products overnight.
- 8. ACCESS: It is preferred that products and booth materials be hand-carted to the vendor space. Vehicle access, which is limited to certain areas and times, will require PROOF OF INSURANCE, WHICH MUST ACCOMPANY THE VEHICLE REGISTRATION. Upon receipt of VALID Insurance a VENDOR PASS will be issued for the vehicle. There will be NO VEHICLE ACCESS in or out during hours of operation. Access will be allowed only before or after operating hours. Saturday morning access with be limited due to the Fun Run. For vendors with large or cumbersome displays, a Friday setup is recommended.
- 9. POWER: There is no access to POWER for NON-FOOD Vendors. If you need to use a generator, make sure to let us know, as your booth location/ position may need to be changed.
- 10. NON-POLITICAL and NON-RELIGIOUS EVENT: This event is not designed to promote any political or religious cause. No political or religious material, including but not limited to signage, banners, brochures, etc. may be posted or present at vendor booths or any associated physical element on event grounds. (NO Approaching or soliciting.)

Before the event and upon receipt of the completed registration, directions, and maps for access and parking will be shared with the vendor.

NON-FOOD Vendors will be located at Boyd Park, Rocky Reach Landing, Animas Park, Berg East Picnic & playground area, and at the y trail. Children's activities and the Riverkids Tent will be located on the grass area over by the Splash Pad at Berg Park.

Upon receipt of registration and payment, you will be contacted about your booth location.
